- Excellent understanding of chemistry at school level
- Passion for chemistry, teaching and chemistry education in the UK
- An ability to explain complex chemistry ideas at school level
- The empathy, respect and humility needed to relate well to pupils
- Relevant teaching experience and an interest in working with school-age young people
- Outstanding verbal communication skills
- The personal attributes to be a good classroom manager
- A realistic understanding of teaching as a career
- A desire to teach in England, once qualified

## Are you eligible?

Applications are open to anyone who has:

- a minimum of a 2:2, or is predicted at least a 2:2 and will have graduated by September 2017
- a degree containing at least 50% chemistry or a conditional teacher training course offer
- secured a place on an eligible part-time or full-time unsalaried chemistry teacher training course in England by September 2017 to start in the 2017/18 academic year.

# How to apply

The application process is in two parts: an online application form and an assessment day.

Application deadlines and assessment days will run through the year so you can apply before or after you have secured your teacher training place. However, we strongly recommend you submit your application as soon as possible.

Applications for the 2017/2018 training year will close in July 2017.
